Volunteers from **LEON L. LEVY & ASSOCIATES** recently spent a day helping Philabundance, the region's largest food bank and hunger relief organization. Several employees and members from the Levy family visited the agency's warehouse in North Philadelphia to assemble boxes and pack them with emergency food items for seniors in the area. Along with another group of volunteers, 636 boxes were assembled which equaled 1,800 lb. of food. Leon L. Levy & Associates held a month long food drive in the lobby of 1818 Market St., where the firm is located.

In all, this event helped raise 460 lb. of much needed food.
